



OFFICIAL RULES – Nationwide® #PetsWithTagsGiveaway

These are the Official Rules for the Nationwide® #PetsWithTagsGiveaway ("Promotion"). The Promotion is sponsored by Nationwide Mutual Insurance Company ("Nationwide"), One Nationwide Plaza, Columbus, Ohio 43215.

No purchase is necessary to enter or win. Making a purchase will not increase the odds of winning.

1. Eligibility.

1.1. Open to Legal Residents.

The Promotion is open to legal residents of the fifty United States and the District of Columbia, except where excluded and prohibited by law, who: (a) are 18 years of age or have reached the age of majority in their jurisdiction of residence at the time of entry, whichever is greater, and (b) are legally able to work in the United States. Excluding the states of Georgia, Kansas, Kentucky, Maine, Minnesota, New Hampshire, and Washington. No purchase is necessary.

1.2. Nationwide Excluded.

2. How to Enter.

2.1. Promotion Period.

Nationwide "Scratch & Win" game (the "Promotion") begins on June 26, 2023 at 12:01 am PST and ends June 30, 2023 at 6:00 pm PST ("Promotion Period")

2.2. How to Play.

During the Promotion Period, the Eligible Person will automatically receive one (1) postcard by mail. Each postcard contains a "scratch & win" area that the eligible person must completely scratched off to reveal whether he/she is an instant winner of a custom pet tag. Winner is responsible for scratching their card and claiming their prize.

2.3. Redemption of Prizes

Prize can be redeemed when the QR code on the postcard is scanned using the camera app on a mobile device running iOS 11 or later or most Android 9 systems or later or by calling Nationwide member care at 800-540-2016 to collect. Prize redemption must be in accordance with these Official Rules. Prizes are guaranteed to be awarded but must be redeemed by 11:59 PM PST on Friday, July 28, 2023. Prizes are not redeemable for cash. Prizes not redeemed by the deadline will be forfeited. Failure to follow the prize redemption procedures within the time provided will result in a forfeited prize.
